



## Gift Card Policy

### Terms and Conditions:

These Halo Products Group, LLC ("Halo") Terms and Conditions ("Terms and Conditions") apply to Halo's E-Gift Card ("Card" or "Cards"). In these Terms and Conditions, "you" and "your" refer to the person who has purchased, received, or used the Card, and "we," "us," and "our," means Halo, the issuer of the Card. By purchasing, accepting, or using the Card, you have agreed to these Terms and Conditions and any additional terms and conditions listed on the Card.

**Use:** Cards are redeemable only online at halo-pg.com for the purchase of merchandise. Cards may not be used at any other online retailers. You will be able to check the remaining balance (if applicable) of the Card by logging in to your Halo account. Upon a purchase event, you should receive a confirmation email from Halo. If you do not receive a confirmation email for a Halo purchase, we invite you to contact Support.

**Split Payments:** Split payments are available at checkout as follows. A code is entered in the Card code section when using the Halo online portal for purchases after which you can pay your remaining balance with your preferred online payment method.

**Cash Redemption:** Except as required by law, Cards are not redeemable or exchangeable for cash, check, or credit.

**Not Reloadable or Refundable:** Cards are not credit or debit cards and are not reloadable. Cards are non-refundable.

**Lost or Stolen:** Cards are treated as cash in that lost or stolen cards will not be replaced.

**Expiration:** Cards can be redeemed for up to five (5) years after purchase.

**Amendments:** We may, in our sole discretion, to the extent permitted by law, at any time amend these Terms and Conditions by posting revised Terms and Conditions. Please check back here for any amendments to these Terms and Conditions. Any amendments shall apply to outstanding Cards and all Card transactions that occur on or after the effective date of the amendments, unless otherwise indicated by us. By the acts of purchasing, accepting, and/or using the Card after the effective date of any amendment to the Terms and Conditions, you have communicated your consent to the amendment.

**No Waiver:** Halo's rights to enforce any provision of these Terms and Conditions shall not be waived by any failure by us to enforce the strict performance of any provision of these Terms and Conditions.

**Severability:** If any provision of these Terms and Conditions shall be deemed unlawful, void, or unenforceable for any reason, the remaining provisions shall not be affected, and these Terms and Conditions shall be interpreted as if the invalid provision was not a part hereof.

**Governing Law:** By purchasing, accepting, retaining, or using the Card, you have agreed that the laws of the Commonwealth of Kentucky to such transaction and any related transactions.
